# **NOTICE TO PLAYERS**

# This information supplements the PGA TOUR 2025 Local Rules and Terms of Competition.

### **Out of Bounds**

Defined by white stakes and when the following boundary objects are tied into by white stakes, white lines or dots: perimeter chain link fencing, navy/black mesh fencing, non-course side edge of the cart path (Hole 7) and the course side edge of the internal perimeter road to the left of holes 1, 2, 3 & 4.

#### Note:

- a.) The driving range is out of bounds defined by white stakes, black mesh or navy mesh fencing and facing of the grandstand.
- b.) The PVC pipes along the power line on Hole 1 do not define out of bounds.

### **Penalty Areas**

a.) Dropping Zone for yellow penalty area relief during the play of Holes 13 and 17 (Refer to 2025 PGA TOUR Local Rules - Item 2a). Dropping Zones are located:

Hole 13: On forward tee

Hole 17: On forward tee

- b.) During the play of any other hole, the yellow penalty areasa on Holes 13 and 17 are red penalty areas.
- c.) When tied into with a red line the inside edge of the cart path or cart paths curbing defines the margin of the red penalty area on Holes 3 and 7.
- d.) A portion of the red penalty area to the right of the 11th fairway, right and behind the 15th green and the 18th green is defined by an edge of the structure when tied into by a red line or red stakes.
  - Note: A ball that strikes this portion of mesh or front of the structure has not crossed the margin of the penalty area.
- e.) A portion of the red penalty area left of Hole 12 underneath the concession stand, is in the general area.
- f.) The entire spectator viewing platform behind 18 green including the area underneath it, is in the general area.

### **Abnormal Course Conditions**

- a.) Gallery cross walks completely encircled with green lines are ground under repair.
- b.) The bunker cameras on Holes 16 and 18 are immovable obstructions.

# **Temporary Immovable Obstructions**

Refer to 2025 PGA TOUR Local Rules - Item 10a. Either side relief is available as an extra option for Line-of-Sight Interference, with the Temporary Immovable Obstructions located as follows:

- Hole 6: TV tower behind the green
- Hole 9: Scoreboard back left of the green and the TV tower behind the green
- Hole 16: The concessions and fenced generator right of the fairway

The black fence in the red penalty area right of Holes 14 and 15 fairways is a TIO.

# **Transportation**

Transportation is permitted between Holes 6 and 7 and Holes 18 and 1 (if applicable).
