

NOTICE TO PLAYERS Detroit Golf Club June 26-29, 2025

This information supplements the 2025 PGA TOUR Local Rules and Terms of the Competition.

Out of Bounds

Defined by white stakes and when tied into by white stakes, lines or dots the following boundary objects: perimeter black or white mesh fencing, perimeter chain link fencing and the course-side edge of parking lot curbing.

Note Internal Out of Bounds:

a.) The club's parking lot left of Hole #2 and Detroit Golf Club Clubhouse: The course-side edge of parking lot curbing, parking lot chain link fence, course-side wall of the cart barn, outside edge of asphalt cart path and curbing around the back of the clubhouse and clubhouse wall left of 18 green. A ball at rest beyond the brick sitting bench is out of bounds.
Note: A ball on the roof of the clubhouse or in the gutters is out of bounds.

Note: White stakes with black tops identify, but do not define, out of bounds and are movable obstructions.

b.) Detroit Golf Club Member Driving Range: The wooden base surrounding the range and the course-side edge of the turf mat pad define out of bounds. A ball that lies beyond the base boards is out of bounds. The wooden poles or fence netting do NOT define the boundary.

Integral Objects

- a.) The driving range wooden poles and attached fence netting.
- b.) Elevated wires/cables supporting tree limbs.

Abnormal Course Conditions

- a) Areas devoid of turf and pitted in nature may be deemed abnormal. Please consult a Referee. Relief is not allowed if such turf damage only interferes with a players stance.
- b) Guy wires extending from member range fence poles are immovable obstructions.

Penalty Areas

- a.) Dropping Zone for relief from a yellow penalty area during the play of Hole #14 is located on the left side of the fairway. (Refer to 2025 PGA TOUR Local Rules Item 2a.)
- b.) During the play of any other hole, the yellow penalty area on Hole #14 is a red penalty area.

Temporary Immovable Obstructions

- a.) Refer to 2025 PGA TOUR Local Rules Item 10a. Either side relief is available as an extra option for line of sight interference from the temporary immovable obstruction located as follows:
 - Hole #9: Scoreboard/ShotLink Camera Tripod left of the green and hole Indicator sign/cooler
 - Hole #11: Television Tower behind the tee, tee back sign and hole indicator sign/cooler
 - Hole #12: Scoreboard left of the green
 - Hole #14: Television Tower behind the tee, tee back sign and hole indicator sign/cooler
- b.) The Tournament Operations Area right of the 15th tee and 17th fairway is one TIO and is defined by the hospitality structures right and behind 15 green, the white mesh fence, and blue stakes.

South Course

- a) Short Game Practice Area Bunkers: Practice bunkers are marked as ground under repair and are in the general area (Rule 16.1).
- b) The holes on the South Course that are not being used for the competition are not part of the competition course and are closed.
